For good and valuable Consideration herein acknowledged as received, and by signing the release, upon the terms herewith stated, I hereby give to Billy M. Liner (Photographer) his heirs, legal representatives and assigns, those for whom Billy M. Liner (Photographer) is acting, and those acting with his authority and permission:

A.) The unrestricted right and permission to use, re-use, publish, and republish photographic portraits or pictures of me or in which I may be included intact or in part, composite or distorted in character or form, without restriction as to changes or transformations in conjunction with my own or a fictitious name, or reproduction hereof in color or otherwise, made through any and all media now or hereafter known for illustration, art, promotion, advertising, trade, or any other purpose whatsoever.

B.) I hereby forever release and discharge the Photographer, his heirs, legal representatives, agents, assigns and the party for whom the photographs were made, from any and all claims, actions and demands arising out of or in connection with the use of said photographs or film footage, including without limitation, any and all claims for invasion of privacy and libel. As further consideration for my grant of right, title and interest herein, the photographer agrees to divide pro rate among the models depicted, 10% of his net collected proceeds which exceed \$500.00 per individual license or sale.

C.) Model will receive 2-5 web ready edited watermarked files from each change. The same (2-5) 1200p x 1500p (8" x10") or 1166p x 1752p files @150 DPI will be provided on CD or e-mail in JPG format. Files will be watermarked across bottom with photographers name and year of shoot. Photos marked, as "un-edited proof" will be published to private site for a limited time. Watermarked proof files will be provided at 72dpi 800p x 800p upon request on CD. Photographer will provide 2-3 un-watermarked prints at cost to the model for models personal display (home, and or dorm) you are not granted rights for public display or allowed to copy. Model may use prints for personal portfolio. Prints will be no larger than 1200p x 1500p (8" x10") or 1166p x 1752p Additional files, prints, edits will be provided at a monetary fee.

D.) I hereby affirm that the photographer was profesional in his behavior.

I hereby affirm that I am over the age of 18. I have the right to enter this contract in my own name. I have read the above authorization, release and agreement, at its execution; I fully understand the contents thereof. This agreement shall be binding upon me and my heirs, legal representatives and assigns.
